Who was duly sworn by me and did state that the Defendant, William Michale Hayden, violated LRS 14:42.1, Forcible Rape, within the Parish of East Baton Rouge and State of Louisiana. The Defendant had vaginal sexual intercourse with the victim without her lawful consent by using acts of force while the victim was twelve (12) years of age.

On August 29, 2014 Detectives with the East Baton Rouge Sheriff's Office were contacted by the victim who advised that she was vaginally raped by the Defendant while she was staying with the Defendant and his family at their apartment located at 3484 Cedarcrest Avenue, while she was twelve years old. The victim stated that she and the Defendant are

The victim stated that she is currently 34 years of age and that this incident occurred approximately 22 years ago.

On August 30, 2014 Detectives met with the victim at her residence where she describes the rape in detail. The victim stated that she was living with the Defendant and his family after being displaced by a house fire. One night she was asked by the Defendant if she wanted to get high. The victim said yes, and the two began smoking Marijuana. After smoking the Marijuana, the victim said that the Defendant then placed his hand over her mouth to prevent her from screaming and laid his entire body weight on top of her. The victim stated that she could not move with the Defendant laying on her. The Defendant then removed her panties and pajama shorts and vaginally raped her. The victim stated that after the act, the Defendant told her not to tell anyone that this happened. The victim stated that she was reluctant to come forward with the accusations because she did not know if her family would believe her. However approximately four years ago she told her husband that she was raped by the Defendant when she was twelve years old. Detectives were able to confirm this after an interview with him.

Detectives requests that a warrant for the arrest of the accused be issued.
